**Permit fees shall be calculated by the Fayette County Building Department and is due when approved plans have been processed and are ready to be picked up. Permits are valid provided work has commenced within 12 months from the date of plan approval. One extension shall be granted for an additional twelve-month period if requested by the owner at least ten days in advance of the expiration of the approval.**
